### **1. MINIMUM EDUCATIONAL QUALIFICATIONS**

#### **A: CATEGORY-1 GRADUATE APPRENTICES:**

Must satisfy one of the educational qualifications given below :

- A degree in engineering or technology granted by a statutory University.
- A degree in engineering technology granted by an institution empowered to grant such degrees by an Act of parliament.
- Graduate examination of professional bodies recognized by the Central Government as equivalent to a degree.

#### **B: CATEGORY-2 TECHNICIAN (DIPLOMA) APPRENTICES:**

Must satisfy one of the educational qualifications given below:

- A diploma in engineering or technology granted by a State Council or Board of Technical Educational established by a State Government.

(b) A diploma in engineering or technology granted by University.  
 A diploma in engineering or technology granted by an institute recognized by the State Government or Central Government as equivalent to (a) and (b) above.

- II. **AGE:** 18-27 years as on 01.11.2022. Relaxation to reserved category as per guidelines in this regard.
- III. **RESERVATION OF VACANCIES:** Guidelines on reservation for SC/ST/OBC under Apprentices Act and Mormugao Port Authority will be followed. Those candidates who are claiming reservation under SC/ST/OBC shall provide a certificate in this regard, failing which their claim for reservation will be considered as "General" category Only.
- IV. **DURATION OF TRAINING:** The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act, 1973.
- V. **SELECTION PROCEDURE:** The final rank list would be prepared according to categories General/SC/ST/OBC on the basis of marks obtained by the candidates, The Selection will be made from the candidates who fulfill the minimum standard educational qualification and medical fitness.
- VI. Only those candidates will be considered for the apprentice engagement who are based at Goa.

- XIII No Engineering Graduate or Diploma Holder or Vocation Certificate holder who had training or job experience for a period one year or more, after the attainment of prescribed qualification shall be eligible for being engaged as an apprentice under the ACT.
- XIV. A person who has been a Graduate or Technician apprentice under the Act and in whose case the contract or apprenticeship was terminated for any reason whatsoever shall not be eligible for being engaged as an apprentice again under the Act without the prior approval of the Apprenticeship Adviser.
- XV. MPA may in the first instant make selection from the list of candidates by preparing list directly from the student data base from the national web portal ([www.portal.mhrdnats.in](http://www.portal.mhrdnats.in)).
- XVI. The candidature of applicant would be provisional and subject to subsequent verification of certificates and testimonials.
